

Pastor Ed showed us a short animated video about Martin Luther, and several readings were shared.

The minutes of the October meeting were read. A motion was made by Marcia Meyer and seconded by Janet DeLong to approve the minutes. Motion carried.

Pat reported that the month-end balance for October is \$12,191.76. A motion was made by Janet DeLong and seconded by Joanne Stumo to approve the report as presented. Motion carried.

Old Business

<u>Rummage Sale</u> – Very successful. Thank you to everyone who helped in any way. We took in \$4,421.67. A motion was made by Cathy Loverude and seconded by Janet DeLong to give \$2,500 toward the parking lot repair. Motion carried.

New Business

- A 10-foot Balsam Hill Christmas tree was donated to the church, and it will be put in the fellowship hall for the Christmas season.
- A motion was made by Debbie Raether and seconded by Kate Koehler to have Cathy Loverude look into a circular rack to display our greeting cards. Motion carried.
- <u>Poinsettias</u> A motion was made by Cathy Loverude and seconded by Jeanne Wilman to have the Ladies Aid pay for the balance if 12 are not sold. Motion carried.
- <u>Wreaths</u> A motion was made by Debbie Raether and seconded by Kate Koehler to buy two cross-shaped wreaths for the west side of the church. Motion carried.
- <u>Santa Sack</u> A motion was made by Debbie Raether and seconded by Janet DeLong to collect items for the CRA for Christmas. Motion carried. We will also fill purses for the women at the shelter. Nancy will check with them to see what their needs are and ask about the possibility of providing Christmas dinner food items.
- <u>Secret Santa Tree</u> A motion was made by Cathy Loverude and seconded by Nancy Danielson to participate in the Salvation Army Secret Santa project. Motion carried. Cathy Loverude will head the project.
- We will fund the Christmas treat bags for the Sunday School children.
- <u>Christmas Luncheon</u> <u>All</u> of the ladies of the congregation are invited to a luncheon on Wednesday, December 3, at the Village Pizzeria at 12:00. Meals will be paid for by the Ladies Aid. Please bring food pantry items (but bring them to the church instead of the restaurant).

Mike Sandell called the meeting to order at 7:04PM. Mike had a devotion and prayer.

The minutes of the October Parish Planning meeting were reviewed. A motion to accept the minutes as presented was made by Patty Kuhl and seconded by Larry Loverude. Motion carried.

Treasurer's Report

Pastors Report

Pastor Ed Clemens was not present at the meeting d/t a vacation. Mike Sandell called pastor by phone as he travelled. By phone, Pastor reported that in October there were four Sunday services, with an average attendance of 69.25 per Sunday.

Upcoming Events:

Lake Wapo youth event this coming Sunday, November 15 hosts gr 6-12 Sunday 2pm-4pm and Redeemer will be providing a drink and snack.

Advent theme will be "Something Better" – Hebrews 1:1-14.

There is a Thanksgiving Eve service, no communion.

Board Reports:

<u>Education/Youth:</u> Four youth attended the October Redeemer youth event with pickle ball and games back at the church. The Christmas program has been selected. The youth will be making Christmas cookies on December 13th, Christmas caroling on December 14th, and their Christmas program on December 21st. Redeemer is providing the drink and snack for the Wapo youth event on November 16th.

Evangelism: No report.

<u>Fellowship</u>: Advent soup and sandwich sign-up sheet is hanging on the bulletin board. The Hanging of the Greens is scheduled for December 3rd at 4 pm.

<u>Lay Ministry:</u> The Lay Ministry met on November 2nd and duties were assigned for December. November Lay person lead services: Sunday, Nov. 9th – Larry Loverude, and Sunday, Nov. 30th – Mike Sandell. On call Pastor during vacation will be Pastor Tom Hahn, phone #715-421-9072. November and December Special Services: Nov. 26th Thankgiving Eve service at 4:00 pm, Midweek Advent services are Dec. 3rd, 10th, and 17th at 6:30 pm, December 24th Christmas Eve service at 6:30 pm, and December 25th Christmas Day service at 9:30 am. The average church attendance for October was 69.25. Social Ministry: Amery Food Pantry -\$500, Northwoods Homeless Shelter - \$200, Salvation Army of Polk County - \$250, and WPCA Radio - \$50. All the Social Ministry requests were submitted to Peg to pay. Jerry will be gone from November 28th - January 10th.

<u>Properties:</u> Thank you to Sandy Young for cleaning the church during October and to everyone who helped with the church clean-up after the garage sale. Thank you to Jeff Young for repairing the furnace in the sanctuary. The air conditioning unit has been purchased. The 3 doors (music room, library, and Pastor's office) have been replaced, but still needing some touchups. The cost was \$9,420. 44 for the doors. The Fellowship door will still need to be ordered to be replaced for the future. The toilet in the bathroom off of the kitchen has been repaired. As always, please let us know if you notice something that needs repair.

<u>Stewardship:</u> Counting schedule for 2026 is complete, with some new members. Envelopes are available and boxes.

<u>Ladies Aid:</u> Rummage sale was a success, taking in \$4,421.67. \$2,500 will be given from that to the parking lot. Many Christmas activities are coming up: Santa Sack for CRA, Secret Santa Tree, Christmas Sunday School treat bags will be funded by the Ladies Aid. All the ladies at Redeemer are invited on December 3 for a Christmas Luncheon at the Village Pizzeria of Amery at 1200 on December 3rd.

<u>Public Relations</u>: Gift cards are going well. In the checking account for public relations there is approximately \$1800.

Old Business

Fall dinner: 264 people were served. We made \$3009 and \$75 was donated to cut back on cost. \$2448.15 will be given to the parking lot. Thank you to Nancy Danielson for all her planning and directing. Thank you to Dan Meyer for fixing the dish washer.
